This is a course on the politics of the European Union. It will start with a brief history of European integration ideas and then examine in some detail EU's institutions and their effects on domestic politics in EU's current and would-be member states. The theoretical and conceptual focus will be on the process of Europeanization of domestic European politics, rather than on the intergovernmentalism, i.e. relations between states, that motivated earlier studies of European integration. In other words, this is more of a comparative politics course, than an international relations course.

## **Required Readings**

This course requires a moderate amount of reading, but many of the articles are challenging either conceptually or methodologically. Plan accordingly. Do NOT fall behind, because you will not be able to skim the readings to catch up. Readings include:

# **Course Obligations**

Students will be evaluated based on four measures:

- 1) Conference participation (10%)
- 2) Midterm (30%)
- 3) Infographic (20%)
- 4) Final (40%)

#### Conferences: 10%

You should register for a conference time on Minerva as soon as possible. Conferences will be led by the TA. Conferences will begin during the third week of classes (the week of Sep 17<sup>th</sup>). Half of your conference grade will be based on attendance. You are expected to attend all conferences. The other half of your conference grade will be based on the quality of your participation in group discussions and activities.

### In-class Midterm: 30%

The midterm will be given in class on October 24<sup>th</sup>. The midterm will consist of term identifications and multiple-choice questions. The material will be drawn both from lecture and from the readings. Practice by studying the multiple-choice questions available with each

# Infographic: 20%

The class will break up into small groups (up to 5 people). Each group will research a topic related to the EU and will present the findings in the form of an infographic. Infographics tell a story with numbers and pictures; they present data in an easily digestible and visually appealing manner to simplify complicated issues for a broader audience. Possible topics include: (1) The enlargement of the European Union; (2) The EMU and the Monetary Crisis; (3) The EU and Migration; (4) Poland and Art 7; (5) Elections to the European Parliament. You will form groups and pick a topic after the midterm on October 24<sup>th</sup>. Each group will submit a brief plain text draft (250 words) on November 9<sup>th</sup>; your final infographic assignment is due on November 30<sup>th</sup> (all deadlines: 11:59 PM on MyCourses).

#### Final exam: 40%

A cumulative final exam will test your ability to integrate a theoretical understanding of the EU with practical knowledge of the day-to-day workings of the EU. For the final, you will be writing a number of short essays. The date for the final exam will be set by the university.
